1. ELECTION OF CHAIRMAN

Scoping Report

The Scoping Report was sent to Natural England, the Environment Agency and Historic England on 04 May 2018 for a five-week consultation period. At the end of this period the Parish Council had only received a response from Historic England which has been passed onto Navigus.

Cllr E Townsend advised that Waverley Borough Council had passed the new Land Availability Assessment (LAA). The Members discussed the call for sites in detail and the need to have sufficient sites to meet Cranleigh housing numbers required by Waverley Borough Council's Local Plan.
